LETS TRY TO LOWER OUR MONTHLY SEWER COSTS

Our sewer fees are much higher than originally expected due to unforeseen construction costs. The Sacheen Water and Sewer District is submitting a request for debt relief through the State Legislature in order to be even stronger partners in the development and construction of the Sacheen Waste Water Collection and Treatment System. As Sacheen Lake is the headwaters to the West Branch Little Spokane, our sewer project has a positive impact on more than just Sacheen Lake 2.5 million is the amount being requested from the 2016 budget.

YOUR HELP IS VERY IMPORTANT

We all need to band together and write letters to our representatives, state senator, county commissioners, and governor explaining how this increased fee impacts us individually. All requests for proviso monies are voted on by the entire legislative body, so if you know any other legislators or senators, contact them as well. We need all the support we can get! Talk to your neighbors and ask them to write as well. If we can show overwhelming involvement and need, we will have a much better chance of having our request granted.

<u>Tell your own story of the need for assistance to reduce your monthly/annual expense for the project.</u>

Your letter should be one page and <u>sent by US mail.</u> Emails are okay, and effective as a secondary mailing. The letter should only include your personal situation, your name and address, and it should reference Sacheen Lake. Thank you all for continuing to support the work of the Sacheen Lake Water & Sewer District through the passage of the M&O Levy in November. This allows the Board to continue to serve the needs of and be good stewards to Sacheen Lake.

We would be remiss if we didn't recognize Gary Garrett for his six years of service as a sewer commissioner. Gary came to the board with a mission of getting sewer for Sacheen Lake and was successful in that mission. His willingness to serve is greatly appreciated. Thank you Gary.

As was noted on the front page, we continue to look for debt relief for our new sewer system. Please remember that your board members are also lake residents and pay the same fees for their sewer service and are thus motivated to reduce our payments. We are requesting debt relief through the legislature that would increase the amount the State contributes to our project funding through the legislature's budget process. This request is being made with the idea that the State be an equal partner in the cost of protecting Sacheen Lake as well as all the lakes, rivers and streams that are downstream of Sacheen Lake.

Please consider writing your representatives and tell them your story. Those of you who don't live at the lake full time, please write your home representatives as well and tell them your story. They will have an opportunity to support this request through the legislative process. If we could get \$2.5 million in debt relief, it would significantly reduce the total cost of the project.


The community of Rockford did such a campaign and was awarded \$1.2 million in proviso money last year, so please don't consider this a wasted effort. We have worked hard to bring an excellent sewer system to Sacheen Lake, let's make one more effort to bring the cost of that effort down.

Last year \$130 million was given through this program.



Finnila Park - An Overview pronounced FIN - i - la (does not rhyme with vanilla)



Finnila Park was first purchased around the turn of the century by Andrew Finnila who arrived from Finland in 1888, and made his way through the Midwest before settling down in Spokane and acquiring approximately 200 acres bordering Sacheen Lake. He married Louvisa Haarala in 1895 in Spokane, and they had seven daughters and one son. Their only son, Lawrence, drowned in Sacheen Lake in 1918, due to a seizure, at the age of twenty-four, and their oldest daughter, Johanna died of tuberculosis in 1924 at the age of twenty-five.

The property was than divided into six parcels for the six remaining daughters. His last living daughter, May KinCannon resided year round on

the property with her husband Sam, until he passed away in 1999, after which she continued enjoying summers at the lake until her passing in 1971 at the age of ninety-seven.

In 1902 they erected their first building, a log sauna, that is still used by the family today. Andrew (Bill) built a sawmill right next to what is now highway 211 and ran a successful business for many years.

According to local records, the family moved onto the property as their prime residence in 1926 or 27. Grandson Denny McMann, remembers seeing several of the sawmill structures, when he first started coming out to the lake as a four year old in 1945. When Nancy McMann, wife of grandson Gravin, arrived at the lake in 1971, there were still visible tracks running up and down the property that were used for transporting the first and second growth trees to the mill.

The bulk of property was sold, first by Andrew Finnila, and then by his Daughters. There are about twelve acres today. The property is currently owned by the ancestors of Lillian McMann, the fourth daughter, and the ancestors of Eva Senna, the fifth daughter, with a small piece owned the Andersons, who are not part of the family. (Maury and Nancy Cain reside on the property once owned by daughter number three, Matilda Atherton.)

Track A, the lakefront piece of property, is owned equally by all, and is designated to remain natural for the enjoyment of all the family members.
