Department Of Ecology

DOE fund is building up well with regular monthly payments. There is no recommendation of rate change to this fund.

Public Works Trust Fund

- Public Works Trust Fund interest only payment is due 6/1/17.
- Annual principal and interest payment due June 1 of each year to be paid according to the amortization schedule.

- A. Begin monthly billing as fees and charges with the January billing.
 - This would bring in an annual income of \$165,120 (our first annual Public Works payment due 6/1/18 is \$156,952)

• Full Hookup: \$45 (\$45 x 275 x 12) \$148,500 annually

• Stub: \$35 (\$35 x 33 x 12) \$13,860 annually

• CC: \$125 (\$125 x 12) \$1,500 annually

• OS: \$105 (\$105 x 12) \$1,260 annually

Total: \$165,120 annually

- B. This year, a one time fee is necessary & would net \$178,710 to be used to pay part of the interest due June 1, 2017
- Adding the 5 monthly payments from Jan. to May would net \$67,140 for a total of \$245,850
- The remaining amount needed to pay the interest payment due 6/1 could come from the ECY debt service account.

ONE TIME annual payment to be due in March of 2017 that would bring in \$178,710
