January 18, 2017

The meeting was called to order at 5:00 pm with the pledge. Commissioners Johnsen, Pearman and Quick were in attendance as well as DM/Pearman.

-C/Pearman reviewed the agenda.

-Commissioner Pearman was called out at 5:07.

RATE HEARING: DM/Pearman presented rate proposals for 2017

- 1. ECY fund is building up well with regular monthly payments. I do not recommend any rate changes to this fund.
- 2. Public Works Trust Fund interest only payment is due 6/1/17. After that there will be an annual principal and interest payment due June 1 of each year to be paid per the amortization schedule.

Many people have asked when this annual payment is to begin and many have asked if we could bill it out monthly as fees and charges instead of an annual payment. I would like to propose that as we are behind in the billing of PW reimbursement that we

A. Begin billing as fees and charges with the January billing. This would bring in an annual income of 165,120 (our first annual PW payment due 6/1/18 is 156,952)

This one-time fee would net \$178,710 to be used to pay part of the interest due June 1. The 5 months' worth of payments would net \$67,140 for a total of \$245,850 the remaining amount needed to pay the interest payment due 6/1 I suggest come from the ECY debt service account.

- 3. Settlement payment Using \$300,000 as District responsibility and not having the financing worked out, I suggest that we split that amount evenly over each ERU for a monthly payment of \$8
- 4. System Operation & Maintenance

Nathan has passed his operator's test and per policy he gets an additional \$1 per hour and then another \$1 per hour with the full certification. He should get that later this spring. I recommend increasing the O&M rate by \$2 per month to cover this and other operating expenses.

Call for comments

-M. Kanyer suggests we take harder look at numbers because we will have challenges to special benefits. Don't think it's going to go away so make allowances for it.

-D. Kanyer asks why the amounts being paid to DOE the same for stub lots as full service

-J. Johnsen asks what the repercussions are for someone who has a lien on their property. Mostly effects cost of getting loans.

-M. Kanyer the LID process required proof of special benefits, by not exercising the LID for assessments, it changes the right to challenge

-J. Johnsen questioned whether the project was presented through LID process both times.

-M. Kanyer comments that LID was the funding mechanism and asks how many times can the public be misled.

Requests for comments were made three times.

-J. Johnsen notes that the annual rate for PW goes down as interest is paid.

C/Johnsen MM to accept the rates for 2017 as presented. C/Quick seconded the motion and the motion was unanimously passed.

ECY's new EAGL system so slow in making payments that there was never an opportunity to do a separate pay request because contractor payments were already delayed. Finally paid it back in April 2016 when I went ahead and submitted the reimbursement request along with other pay request. Loan close-out date has been extended to end of 2017.

Request for comments made three times with no response.

C/Johnsen MM to approve the 2016 supplemental budget as presented. C/Quick seconded the motion and the motion was unanimously passed.

C/Quick MM to approve the 2017 Ecology Debt Service budget as presented. C/Johnsen seconded the motion and the motion was unanimously passed.

C/Quick MM to approve the 2017 Public Works Debt Service budget as presented. C/Johnsen seconded the motion and the motion was unanimously passed.

The next regular board meeting will be February 8, 2017 at 5 pm. Meeting was adjourned at 5:46.
