Operators report:

No service calls this month, located stubs at Poirs Lot 9 and 10, Serviced grinder at 8532 FVR needed on/off switch sealed. Continued repairing irrigation lines. Collected samples on each lagoon and influent samples. Found whale gone, met with Kris to make sure we are ready for the ecology meeting. Deep Cleaned the head works building and the fine screen, prepped the grounds for the ecology inspection. Serviced the pump at 181 east shore rd. Met with Kris and ecology for the inspection. Need to consider other options for installing pump as Fogel Company is not returning calls. Look into renting a boom truck if possible. Need to aerate all lagoons. Start pumping in March and April for the repair on the Whale that has returned. Let it ride until DOE requires repair. Low down trees in the forest have to be tested when removed. Please check to see if we can burn a slash pile.

Spoke with the land owner and sent him the information we received and he is working on the petition.

We received a letter from Connors/Dullanty to not pay M&O fee while their cabin is being built as they have no residence at this time. The commissioner said no as it would set a president for part time residents.

Budget was discussed and tabled until December to see if levy passes.

Increase in M&O fee was discussed because of aging infrastructure and tabled until December. Need to put notice in miner for both of these discussions in November. For December meeting.
