Had a spike in BOD in irrigation last month, taking samples from each lagoon to find out what is causing the spiking. Picked up the motor for the irrigation pump, we are missing some of the small parts for install., trying to contact Paul and no response. Spoke with Fogel abut installing the irrigation pump They said hey could get to sometime in September. Will ask for an estimate for the install. We received two grinder pump vaults from E-One. Replaced all switches and stator on the spare pumps.

Need to proceed with a petition from the land owners to start process. Will contact land owner.

Rod spoke with Diversified Lube and they had no authorization or estimate to repair.
