Operator report for 2 months. Sampled soil and groundwater. Put a camera down leak protection pipe between the lagoon liners on lagoon 3 and it is full. This is the treated wastewater. There is a breach on the first liner. Not losing water, need to find liner repair company.

The lift station had a relay go bad so a new one is ordered.

K & N electric said the parts for the irrigation pump motor are obsolete. Will keep looking for a new bonnet but may have to make one from scratch. Need a lift rental to reinstall pump.

Nathan made a proposal to purchase 2002 GMC Siverado. A price of 8500.00 was agreed upon and conditions of payment are snowplowing and overages applied to debt. We are to stay on title as registered owners until debt is paid. MM by Randy to sell, 2<sup>nd</sup> Shaun passed unamiously. Snowplowing is 125.00 hr up to 6" and 25.00 for every additional 3".

The 2024 Budget was approved. A resolution was signed.

There was a public discussion on the rate increase. And transparency of finances. The cost of equipment and repairs has gone up substantially. The system is getting older and requiring more repairs as equipment wears out. There is also liner repairs that need to be done. It was agreed to post the financials semi annually on website. Randy MM for 2.00 a month increase 2<sup>nd</sup> by Shaun and passed unanimously.
