Kate Hupp is requesting a schedule from our engineer regarding irrigation to empty lagoon. Sewell is estimating \$25,000.00 for this. No progress has been made. Found an irrigation 5 yr plan and sent it to Kate, she said she has it and it is not what she is looking for.

No irrigation has started per Ecology waiting for an emergent plan and a long term plan to put in our O&M manual.

We received the estimate for repair from Northwest linings, but need to empty lagoon and clean to make a plan for repair. They are ready to repair as soon as it is empty and cleaned.

Nathan was not at the meeting.

Need to contact Sewell to see if we can split the bill on Lagoon 3 report.

It was decided that the park will remain closed due to fire danger until further notice. The garbage cans will be removed in all areas except by the bathrooms. A No illegal dumping sign is being made at Petroglyph.

Have not heard anything about the beaver dams.

Karlene Perry mentioned that the weedinator had come thru areas on the lake and there is now weeds floating everywhere. Not encouraged to use. We will be treating the milfoil soon.

There is trees on the trail at the park that need to be removed.
