Everything is running smoothly. One service call swapped pump out, believe the on/off switch is stuck. Collect samples for the effluent and groundwater samples, took to lab.

Irrigated and drained Lagoon 3 from 7/12 until 7/28/2024. Lagoon 3 is dewatered except for the liquid between liners.

Submitted a bid for cleaning the lagoon \$98,355.00 the commissioners are looking into this amount, They have requested we call and have someone from NWLinings to come and give us guidance as to what we need to do for repairs. They are sending some one Wednesday 8/18/2024 8:30am.

Park is still closed for the season, Working on fire suppression with DNR.

The beaver dams have the lake level up and SLA is requesting we call the beaver trapper. For dam 3.

The water quality of the lake is back, still trying to get better interpretation of results.

## **Public Comment:**

Grant asked about Fire Suppression at the park, the commissioners are working with a forester to evaluate and will need DNR approval.

SLA would like more information when the lake is treated and a longer notice.

Beaver tubes are clogged, need a trapper
